- Introduction. This Privacy Policy outlines how we collect, use, and protect your personal
 information. By using our Service and contacting us via the contact form on the website or
 calendar feature or other available means, you consent to the practices described in this Privacy
 Policy.
- 2. Information we collect. We collect and store the following types of information: Client Information: To provide our services, we may collect and store your email address, client identification data and numbers as well as legal names. Contents and/or files: You may share your contents and/or files with us for the purposes of enabling the provision of services. These contents and/or files may be accessed by us or our employees and/or subcontractors to fulfill your service requests.
- 3. **Purpose and basis of processing.** The processing of your data is necessary to close and perform the contract to which you are a party or to take action at your request before concluding the contract.
